### **Life Story**

Daniel Dunn was born in Bermondsey, London, in England around 1893. His mother died in 1899, and his father married his second wife, Catherine Sarah Franks, in February 1902. On the 12<sup>th</sup> August 1909, the family of three disembarked *Otway* at Fremantle. By 1910, The family were living at Main Camp, York, where Daniel Senior was working as a carrier.

Around the age of twenty-one, young Daniel became the leader of Scout Troop Fourteen at York, and his name was added to the W.A. Scout Roll of Honour in October 1915.

A letter in his service record file notes that Daniel was working as an orderly at the York Hospital before he enlisted in the A.I.F. His address was noted to be "care of Mrs Bygraves, Avon Terrace, York," and his father, Mr D. Dunn, was listed as Next of Kin.

Daniel enlisted as a Private on the 16<sup>th</sup> January 1915 and, on the 22<sup>nd</sup> February, he embarked aboard HMAT A50 *Itonus* to join the 16<sup>th</sup> Battalion, 2<sup>nd</sup> Reinforcements on route to Gallipoli.

On the 21<sup>st</sup> August 1915, Daniel suffered a gunshot wound to the left wrist and was transferred to hospital in Malta. Discharged from hospital on the 1<sup>st</sup> September, he remained on the island until he embarked H T *Karoa* on the 26<sup>th</sup> September for Alexandria, in Egypt. From there, Daniel embarked on H S *Borda*, in Alexandria, on the 18<sup>th</sup> October, to return to his unit.

By August the following year, Daniel was fighting in France. On the 10<sup>th</sup> of the month, he was wounded again (shell shock) but was able to rejoin his unit after only five days. At the end of November, Daniel was taken sick to hospital from the Field and spent another eight days recovering.

On the 13<sup>th</sup> January 1917, while on leave in the U.K., Daniel was admitted to the 2<sup>nd</sup> Aust. Auxiliary Hospital in Southall, England, suffering from "I.C.T. left toe" (inflammation of the connective tissue of the left toe).







He remained there until discharged on the 1<sup>st</sup> February. A 1918 letter sent by his father in York to the War Department stated, perhaps mistakenly, that Daniel was also suffering from shell shock at this time.

On the 11<sup>th</sup> April 1917, Daniel was reported as Missing in Action in the Field. This date coincides with the date of the First Battle of Bullecourt which began on that same day. The 16<sup>th</sup> Battalion's War Diary records that the Battalion commenced battle at 4.45am with seventy officers and 700 other ranks going over the top in four waves. By 11.30am, when the decision was made to withdraw the battalion back to their original line, only three officers and eighty-seven other ranks returned.

At the beginning of May, word was received that Daniel had been captured at Riencourt and was a Prisoner of War in Germany.

Daniel spent the rest of the War interned at Limburg Camp in Germany. He was repatriated to England on the 4<sup>th</sup> January 1919 and, four months' later, finally boarded a ship to Australia. His war finally ended with his discharge at the end of July 1919.

On the 16<sup>th</sup> January 1921, Daniel announced his engagement to Margaret Mary Rose Fox of Cottesloe. At that time, his address was given as East Fremantle. After their marriage in 1921, they were to have seven children; Alice Margaret (1922), a stillborn child (1923), Frederick Daniel (1924), Henry Ormonde (circa 1926), Edmund William (circa 1929), Annie Belle (circa 1931) and Joseph Thomas (circa 1933).

From 1929 to 1954, electoral roll enrolments showed the family home was at 12 Coode Street, Maylands/Mt Lawley.

Daniel Dunn died on the 24<sup>th</sup> September 1952. A funeral notice requesting members of the Inglewood Lodge, No.112 of the United Ancient Order of Druids, attend his funeral noted he had been a past Arch Druid of the Lodge.
