End of Year Financial Situation

The York Shire Council recorded a surplus of \$750,473 for the 2009/2010 Financial Year. The surplus can be attributed to economic stimulus measures brought in by the Federal Government such as the Regional & Local Community Infrastructure Program and early payment of a portion of the 2010/11 untied Grants Commission grants. Other contributors to the surplus include incomplete road construction works, unspent SEAVROC funds, reduced staff costs due to a number of new positions not being filled or only filled for part of the year and some existing positions becoming vacant during the year thus not being filled for a full 12 months. Most of the noncompleted works have been included in the 2010/2011 budget. These unspent grants and SEAVROC funds have been placed into reserves to be drawn upon in 2010/11.



New starting blocks at the York Swimming Pool were installed using funds provided by the Regional & Local Community Infrastructure Program.

Valuations

Rural land was re-valued during the period in accordance with the requirements of the Department of Land Information to value rural land on an annual basis.


Smaller rural land holdings valuations increased slightly but with the reduction in the rate in the dollar set by the Council the majority of small land holdings rates levied for 2009/10 were reduced considerably from the previous financial year. Broad acre holdings had large increases in valuations combined with the reduced rate in dollar actual rates levied were much higher on these properties for 2009/10.

GRV values remained the same as 2006/07 due to GRV revaluation only being carried out by the Department of Land Information every five years. The next GRV valuation will be applied in financial year 2011/12.



Community Assistance & Support

Once again community organisations were provided with financial assistance through direct sponsorship and donations. The Council budgeted \$24,547 in direct sponsorship assistance as well as picking up the tab for the free use of facilities and the use of, transport and cleaning of the A.R.O.C. portable toilets and lighting plant for a number of events. This would have easily mounted to more than \$5,000 in indirect assistance. Whilst the whole amount was not expended some of the projects were transferred to the 2010/11 financial year. In addition to this the Shire provided direct cash assistance to help fund the operations of the York Tourist Bureau and provided rent free use of Town Hall Offices to the Tourist Bureau.

It should be noted that the above contributions do not include in-kind assistance provided to many community organisations and contributions paid to organisations towards the development of Council owned facilities.

In 2009-10 the Shire also made a donation to the Shire of Toodyay. The sum of \$3000.00 was donated to the Bush Fire Disaster Relief Appeal. The Shire was pleased to be in a position to be able to contribute to the disaster in the Shire of Toodyay and hopes that York will never be placed in a situation where we require a similar appeal to help our community.

Library

The York Library has had a busy year with an increase in usage and a marked increase in the number of items available for loan and the number of people that have joined the library.

Library issues overall increased in 2009/10. There has been a drop in the number of Non-Fiction items issued over the year, but Adult Fiction and Junior items increased in usage. This can perhaps be attributed to the rise in the popularity of the internet with more and more people doing their research on-line. Children's story time has remained very popular and the library now participates in the "Better Beginnings" program which encourages parents to read to their children.

There has been a marked increased in local book stock. The local book stocks have increased by 1117 this year .The growth in book stock can be attributed to the generous donations that we received from our community. Shire funds have also been used to purchase some of the latest bestsellers so that our readers do not have to wait months to read their favourite authors.

We have had a significant increase in the demand of loan items from other libraries for York Library users. The number of library memberships has increased by 140 borrowers.

Residency Museum

The Museum had a busy year as usual. In addition to the ongoing collections care, answering of public enquiries and other museum management matters, some of the special projects/achievements this year have been:

Archaeological Dig

Led by Sean Winter, a team of PhD students from University of Western Australia undertook a dig at the rear of the Museum, finding evidence of several Convict Depot buildings and structures. His full report and the objects collected during the dig will in due course become part of the Museum collection.

Replacement of ceiling in Room 2 of Museum

An unexpected collapse of the original ceiling in room 2 occurred in May, the plasterwork and vegetable-fibre structure finally giving up after over 150 years. Acting Curator Samantha Good successfully organised the enormous task of safely removing the collections and liasing with the Heritage Council regarding the replacement. The work was funded by the Shire and undertaken to Heritage Council requirements by local contactors.



New exhibition for Room 2 is completed

After the inevitable delay due to the ceiling works, Room 2's new exhibition was completed and tells the story of the development of York in its boom years of the 1890's to 1920's. A different storyboard design was used and many objects that had been in storage for some years are now on display.



New audio-visual equipment installed in Room 2

A TV and DVD player have been installed to play archival film; the first film to be shown is a record of the traditional chaff-cutting process using reaper-binders and a steam chaff cutter, kindly provided by George and Lorna Saunders. Other archival film has also been obtained and this will eventually be provided as a multiple-choice menu that the public can choose from to watch archival film footage.

Both this equipment and the new exhibition above have been funded through a Lotterywest Interpretation of Cultural Heritage grant.

Two Community exhibitions held

The hall display space is dedicated to six-month exhibitions that provide an opportunity for local groups to celebrate their heritage, or other topics with a local theme. "100 Years of Croquet in York" was followed by the current exhibition "Still In Motion – the story of picture shows in York", to coincide with the York Film Society's hosting of the National Conference of Film Societies.

Development of the Ballardong Noongar Six Seasons Garden Walk

Local Noongar community members have been involved in this project that has seen the transformation of an unused section of remnant bushland into an interesting garden walk. It is now full of local native plant species and accompanied by a leaflet explaining the importance of Budjar [Country] and local flora and fauna to the Ballardong people. Students from York District High School created ceramic artworks in the form of rocks decorated with local native animals and the names of the six Aboriginal seasons, which line the pathway. This project has been funded through a Wheatbelt Natural Resource Management Community Incentive Scheme grant.

Record Keeping

A complete review of the Shire of York's Recordkeeping Plan was carried out in early 2010.

Staff worked together to ensure compliance by the due date.

The Shire of York, which is renowned for its heritage values and its commitment to preserving local history, supports the principles of the State Records Act and recognises the importance of establishing and maintaining a reliable and credible Record Keeping System.

The State Records Commission provided the following details on the 23rd June 2010:

At its meeting on 18 June 2010, the State Records Commission APPROVED the amended Recordkeeping Plan (the Plan) for the Shire of York (the Shire).

The Plan demonstrates progress towards better practice recordkeeping and compliance with the minimum requirements of SRC Standard 2: Recordkeeping Plans and SRC Standard 6: Outsourcing.

In accordance with section 28 of the *State Records Act 2000*, the Plan for the Shire is to be reviewed within five years of its approval date. Once completed, a report of the review must be submitted to the State Records Office by **18 June 2015**.

I acknowledge that the Plan indicates a strong commitment to address certain matters within specific timeframes and I would expect that the review will reflect further improvement in those areas identified in the attachment.

Freedom of Information

It is this local government's intention to provide access to requested documents, wherever possible, in the ordinary course of daily work provided that in so doing no harm is inflicted upon the rights or interests of private individuals or commercial organisations.

Where requested documents are of a sensitive nature the application will be dealt with under the provisions of the Freedom of Information Act taking into account all parties concerned.

It is our belief that this strategy will facilitate the provision of information to the public in a prompt and cost effective manner whilst still observing the need to preserve the confidentiality of classified information.

In 2009/10 there were three formal Freedom of Information application received. Those concerned received edited information in relation to their requests.

Planning for the Future

On 5th September 2009, Council adopted a Plan for the Future for the District with the following objectives:

- To obtain Federal and State grant monies that allow the provision of works and services for the growing district
- Maintain Rates and Charges increases that are commensurate with regional and State growth and rate of inflation
- Where practical and necessary, obtain new loans borrowings that allow capital and infrastructure development
- Incorporate the programs and activities proposed in the Plan for the Future in the Annual Budget
- Expend 95% of Capital Works by 30 June each year.

Major initiatives for 2009/10 included:

 Major Plant and Equipment Purchases

Both road construction and plant replacement form significant parts of Council's annual budgets and these items have proceeded in line with Council's long-term plans.

The Plan for the Future will be updated during the 2010/11 year and residents will be given the opportunity to provide input into the updated plan.

Complaints about Conduct of Members

Council is required to report on official complaints that result in action under section 5.110 6 (b) or (c) of the Local Government Act 1995. During 2009/10 no such complaints were received.

HEALTH, BUILDING, TOWN PLANNING, FIRE PREVENTION & REGULATORY SERVICES SECTOR

The Development Services Section of the Council is jointly managed by Mrs Tyhscha Cochrane, Mr Patrick Ruettjes and Mr Gordon Tester and the areas of responsibility involve Environmental Health, Building Control, Building Maintenance, Town Planning and Ranger Services.

Health

There are now two Environmental Health Officers, Mr Gordon Tester and Ms Judith Anderson who are responsible for monitoring various aspects of public health within the Shire. This includes the inspection of food premises to ensure compliance with the relevant legislation, public building inspections, swimming pool inspections and offensive trade monitoring.

These duties are also undertaken on a contract basis for the Shires of Tammin, Quairading and Cunderdin.

Council continued to monitor the structural and operational aspects of all premises to ensure compliance with the requirements of relevant legislation.

21 effluent disposal systems were approved for installation.

Food Act 2008

The Food Act 2008 (the Act) was passed on the 8 July 2008 by the Western Australian Parliament and was implemented on the 23 October 2009. The Act applies to everyone involved in the sale of food in WA.

The Shire of York has now registered all food business within the Shire requiring businesses to complete a Notification and Registration form and pay an annual fee.

Notification and Registration forms have been returned to the Shire. The Shire will issue Certificate of Registrations for all food business under the Act. This Certificate of Registration is now required to conduct a food business in the Shire.

Food Act 2008 has adopted the Australia New Zealand Food Standards Code (the Code) without amendment. The code requires all food handlers to undertake food safety training.

The Shire of York has established a free Online Food Safety Training course to assist food businesses to meet their food safety training requirements under the Act. The Online Food Safety Training was developed by Environmental Health Australia and is being used extensively throughout Australia.

Information from the Notification and Registration forms will be used to undertake a risk profiling of food businesses. The risk profile will determine the frequency of food businesses inspections.

Swimming Pools

The York Public War Memorial Swimming Pool was inspected and sampled regularly.

Inspection and sampling three public swimming pools as defined by the Health Act was undertaken throughout the season.

Samples of the swimming pool water are sent for analysis to a Perth laboratory to ensure they meet the required standards.

The Health Department of WA conducted an audit of all public swimming pools in the Shire resulting in several premises choosing to close their pools to members of the public pending future upgrading of their facilities.


Swimming pool manager Bill Livingstone continues to do an excellent job managing and maintaining the pool.

Upgrades of the chlorination and filtration system for the York Public Swimming Pool are being considered for 2010/2011 financial year.

Building

In order to improve the level of customer service in regards to building matters, Council contracted a professional Building Surveyor who also undertakes building surveying activities in the Shires of Tammin, Quairading and Cunderdin.


In 2009/2010 the Building Control Section of the Council processed 121 building applications. These applications were split into the following categories:

The Council's Officers audit building works to ensure compliance with the approved plans and to ensure that all work is carried out to the necessary standard.

The approximate value of building works in the Shire was \$20.1 million, up 62% in value, from \$8.1 million in 2008/09.

While the number of building licences issued was 15% down on the previous years number of licences issued, the value of the total amount of construction increased by approximately 62% due to two major commercial projects in the York Townsite.

Town Planning

Ms Brooke Newman was appointed as the Statutory Planning/Compliance Officer during the year and commenced in January 2010.

The Council continues to utilise Town Planning Scheme No. 2 to guide development within the Shire in association with the Local Planning Strategy and a series of outline development plans for defined precincts. The Local Planning Strategy, CBD,

Equine Precinct and Industrial Areas have all been the subject of continuous research and development and as the Council develops its various precinct plans it will consult widely with the community and other interested parties.

During the year a total of 66 development applications and 21 subdivision/ amalgamation applications were received by the Shire.

Heritage is an important part of development in York and Council utilises the services of Kris Bizzaca, the Regional Heritage Advisor for the Avon Arc. Due to the need for advice on heritage matters Council utilises 20 hours per month of Kris' time.

Waste Collection & Disposal

The Council again participated in the "drumMUSTER" program. This nation wide program provides for the collection and disposal of used farm chemical containers. A new collection yard was located adjacent to the transfer station and collections are held regularly. 5549 drums were collected under the program this year slightly less than the amount collected last year.

Council continued with its participation in the Mobile Muster program. This program was commenced to ensure that mobile phones and their accessories are recycled. Collection points for mobiles are located at the Shire Administration Office and the waste transfer station.

A total of 1784 tonnes of waste were transported to the Shire of Northam landfill site for the 2009/10 financial year.

A significant amount recyclable material and waste oil were also recycled during the year.

Electronic waste was collected and recycled with funding for this activity having been obtained from the Waste Management Authority.

The skip bin service offered to residents with a bin service continues to be popular. The bulk waste pick-ups which were introduced in 2007 continue to be well received and additional collections were carried out in 2009/10 and will continue into the future.

Building Construction and Maintenance

The Council continues to maintain and improve its assets. This year projects included:

- Recreational Vehicle Dump Point Avon Park
- York swimming pool connected to sewer

Ranger Services

Council's Ranger Ms Angela Plichota has been kept extremely busy in all aspects of her role and for part of this time Ms Plichota was on Maternity Leave. Council would like to welcome Matthew Sharpe to the position who has taken on the new role with vigor and enthusiasm.

Fire control remains a primary responsibility. During the fire season the Ranger takes on co-ordination of the approximate 350 members of the Shire's Bush Fire Brigades through a network of three base stations and 80 mobile units.

Animal Control has also been a priority with educating people on the responsibilities of animal ownership. The occurrence of dogs wandering from their properties or not kept on a lead in public is still steady.

There were approximately 650 dogs registered in the Shire.

Straying stock on the roads has also been a contentious issue with owners needing to ensure their fencing is adequate to keep their stock within.

Ranger Services maintains a constant vigilance with the RSPCA regarding animal cruelty within the district

Disability Access and Inclusion Plan

Council continues to make progress on the Disability Access and Inclusion Plan (DAIP) which was adopted by Council on 16th July 2007. A series of objectives and strategies were included in the DAIP along with a list of 10 recommendations for the delivery and monitoring of initiatives and strategies included in the plan. Council staff will work on an ongoing basis over the coming years to implement those recommendations.

Subject to funding Council is actively pursuing the option of installing an external lift to access the upper floor of the York Town Hall.

Capital Works

Roads to Recovery

2009/10 was the year of Stage 3 of the Federally Funded Roads to Recovery Programmes. \$1,195,356 will be provided over four (4) years for local road projects.

Specific road works undertaken through Roads to Recovery Funding in 2009/10 include the following:

- Top Beverley Road
- Greenhills Road
- ➤ Avon Terrace

Regional Roads

The Western Australian Government provided \$203,287 for works on designated regional roads and Council provided an additional contribution of \$206,009.

Works were undertaken on:

> York-Tammin (Goldfields) Road – Widen and upgrade to 7 metre seal

Black Spots

Council was fortunate to receive \$23,260 funding to improve intersections at York-Tammin/Mannavale Roads and Mokine/Boyercutty Roads through the State Black Spot programme. Council contributed an additional \$36,630 towards these projects. Council will continue to seek funding in coming years through this and other programmes to improve the safety of intersections and other recognised black spots around the Shire.

Municipal Fund

In addition to the works mentioned above Council expended a further \$1,548,792 on transport based works and services which included street cleaning, tree lopping, road & bridge maintenance, road construction, gravel purchases, sealing & re-sealing, culverts & drainage and car park maintenance and construction. Income of \$243,977 was received in 2009/10 to partly offset this expenditure.

Major Works undertaken were:

- Footpaths
- Drainage
- Carparking

It is programmed that similar levels of expenditure will be in place for the next four (4) years with some increased funding for regional roads and bridges.

Over the past few years the Council has significantly increased its expenditure on asset preservation for roads and this preservation effort must be continued if the road network is to be sustainable.

Bridges

The Shire of York \$514,000 through the WA Grants Commission for bridge upgrading and Main Roads WA contributed a further \$257,000. Widening & upgrading was undertaken by Main Roads WA contractors on the bridges on Mannavale and Qualen West Roads to improve road safety and heavy vehicle access.

Private Works

Private works income generated in response to works requests amounted to \$66,229.94. The Council is conscious that its involvement in private works will not be at a detriment to its own works program and of our local contractors.

Recreation Facilities

The redevelopment of Forrest Oval moved ahead throughout 2009/10. Stage 1 saw the appointment of an architect to design a new recreation and convention facility, which includes home and visitor change rooms, trainers and umpire rooms, shower, toilets and disabled facilities. Also included in the new facility will be a ground floor gymnasium with a parent's room attached. A function/convention facility with full bar and a commercial grade kitchen will be a special feature of the new building, along with a large committee room and several office spaces also incorporated.

The oval was realigned from an East/West to North/South perspective, topped with a new turf surface and reticulated. Lights were installed which provides both training and playing standard lighting. This portion of the project was completed in December 2009.

Construction of a new ablution and change room facility for the Hockey Club was handed over in May 2010.

Stage 1 was completed at a total cost of \$1,245,762 which was supported by Community Sporting and Recreation Facilities Funding of \$243,584 with the remainder funded by the Shire of York and community in-kind contributions.

Stage 2 is the construction of the exciting new recreation and convention facility which will commence in November 2010.

Gravel Reserves

The sourcing of gravel to undertake our works programme is a continual struggle as locating quality gravel supplies within close proximity to the job reduces our cartage lead time and overall job cost. Council continues to use a royalty system for gravel which may provide access to gravel supplies.
